



## Highlights of the research programme

The Singapore Sustainable Futures Initiative (SSFI) was established in November 2024 and entered full operation in 2025. SSFI is one of the core initiatives of the Centre for Commercial Law in Asia (CCLA) within the Yong Pung How School of Law (YPHSL) at Singapore Management University (SMU). This is the first annual report of the initiative in what was a highly successful inaugural year of research outputs and societal impact.

The SSFI aims to drive transformative change through futures-focused, interdisciplinary legal research that offers cutting-edge solutions to sustainability challenges. The Initiative is built upon key faculty expertise across international environmental law, biodiversity conservation law and the law of the sea. It also brings together other areas of expertise from SMU Yong Pung How School of Law such as financial law, tort and contract law, and international economic and trade law. The SSFI aims to become a heartbeat for sustainability law research, with a global network from a wide range of disciplines and institutions.

**The SSFI leads the Asia-Pacific Research Alliance on Law and Sustainability**, a consortium that includes SMU, the University of Sydney, the University of Hong Kong and the University of Indonesia. Following successful ‘Law and Sustainability’ conferences at SMU (2023) and the University of Sydney (2024), the Research Alliance’s Flagship Conference was hosted in 2025 by the University of Hong Kong’s Faculty of Law. The next conference of the Alliance has been announced for July 2027 to be held at the Faculty of Law, University of Indonesia.

The research output of the SSFI in 2025 includes an edited book published by Routledge, *The Law of the Sea and the Planetary Crisis* (lead edited by Associate Professor Nengye Liu), alongside peer-reviewed scholarship in top ranked international journals (see full list on page 5). 2025 also brought a number of research achievements for the SSFI, including:

- In December 2025, the United Nations Educational, Scientific and Cultural Organization (UNESCO) favourably evaluated SMU’s application to establish a **UNESCO Chair in Sustainability Law Futures**, with Associate Professor Michelle Lim, a core member of SSFI, as chairholder. The UNESCO Chair will advance futures-oriented approaches in sustainability law, develop and disseminate innovative pedagogies, and support law and policy makers in adopting futures approaches, with particular attention to safeguarding intangible cultural heritage in Asia-Pacific island nations.
- SSFI’s work has earned strong policy recognition by national government and international organizations. Associate Professor Nengye Liu was nominated by **Singapore’s Ministry of Foreign Affairs** as Singapore’s expert speaker at the **13th Expanded ASEAN Maritime Forum** (ASEAN 11 + Australia, China, India, Japan, New Zealand, Republic of Korea, Russia, Türkiye, the United Kingdom and the United States of America) and a member of Singapore Delegation at the 15th ASEAN Maritime Forum in Malaysia in September 2025. Prof Liu was also invited by the **United Nations Office on Drugs and Crime** to attend Maritime Expert Group Meeting on Effective Law Enforcement in the High Seas at the University of Vienna, Austria in June 2025.



- SSFI has strengthened its international profile in polar and maritime governance. Associate Professor Nengye Liu convened the **plenary panel “Asia and International Polar Law”** at the **18th Polar Law Symposium** in Nuuk, **Greenland** in October 2025, which attracted 150+ participants from across the globe. The SSFI has also been chosen to host the **20th Polar Law Symposium** at SMU Yong Pung How School of Law in **November 2027**. This will be the first time for the Polar Law Symposium to be held in a tropical country and Southeast Asia.



- SSFI has secured competitive external funding to convene global dialogue in Singapore. In November 2025, Associate Professor Nengye Liu was awarded a grant by **the Asia Pacific Foundation of Canada** and will host the **1st Asia–Canada Arctic Dialogue** at SMU CCLA on 27–28 April 2026, together with Professor Suzanne Lalonde (University of Montreal).
- SSFI has received competitive funding from **the Korea Foundation** in a project led by Associate Professor Nengye Liu, entitled “Korea and the Antarctic Treaty System in a changing world order”. Associate Professor Liu will work with co-investigators Dr. Hyoung Chul Shin (President of Korea Polar Research Institute) and Associate Professor Cassandra Brooks (Department of Environmental Studies, University of Colorado Boulder) to deliver this project through 2026.
- SSFI is also driving applied, campus-linked sustainability initiatives. Associate Professor Michelle Lim, Dr Patrick Shi and Pam Wan were awarded \$170,000 from the **Singapore Ministry of Sustainability and Environment’s SG EcoFund** to establish a Nature–Food Futures Learning Precinct at SMU, as a hub for hands-on learning and research on native edible plants aligned with Singapore’s Green Plan Food and Nature goals.





### The Evolving Climate Jurisprudence under UNCLOS through International Institutions

Climate change has caused substantial and increasingly irreversible damage to terrestrial, freshwater, atmospheric, and coastal ecosystems. Approximately 3.3 to 3.6 billion people live in highly vulnerable contexts, where human and ecosystem vulnerability are closely linked. Regions with significant development constraints face elevated exposure to climate hazards, increasing extreme weather events have affected millions, reducing food and water security, with the greatest impacts in Africa, Asia, Central and South America, LDCs, Small Islands, the Arctic, and globally for Indigenous Peoples, small-scale food producers, and low-income households. Between 2010 and 2020, human mortality from floods, droughts, and storms was 25 times higher in highly vulnerable regions compared to areas with very low vulnerability. Human activities, primarily greenhouse gas emissions, have unequivocally caused global warming, with global surface temperatures reaching 1.1°C above 1850–1900 levels in 2013–2020.

The International Law Commission, in its 76th Session Report (June 2025), addressed 'Sea Level Rise in Relation to International Law,' clarifying the UNCLOS framework on baselines, preservation of statehood, human dignity, and solidarity in responding to sea level rise. In light of intensifying climate impacts, vulnerable communities have engaged global institutions, including the ILC, the International Court of Justice, and the International Tribunal for the Law of the Sea, to develop climate jurisprudence. This webinar will explore the evolving climate jurisprudence under UNCLOS, focusing on advisory opinions on climate change, ILC insights on sea level rise, and the role of global institutions regarding anthropogenic emissions and transboundary harm.

### The Implications of the Entry into Force of the BBNJ Agreement to the World's Oceans

The Agreement under UNCLOS on the Conservation and Sustainable Use of Marine Biological Diversity of Areas Beyond National Jurisdiction (BBNJ Agreement) represents the most significant development in global ocean governance in decades. Adopted on 19 June 2023 after nearly two decades of negotiations, the Agreement crossed the 60-ratification threshold in September 2023, triggering a 120-day countdown for its entry into force. In accordance with the treaty's entry-into-force clause, the Agreement is scheduled to enter into force on 17 January 2026. The BBNJ Agreement constitutes an integrated framework for the marine genetic resources (MGRs) and fair and equitable benefit-sharing, area - based management tools (ABMTs), including marine protected areas (MPAs), environmental impact assessments (EIAs) for activities in the areas beyond national jurisdictions (ABNJ), and the capacity building and transfer of marine technology for developing states. As the international community and states move from negotiations to implementation, urgent questions emerge about institutional readiness, operationalization of the clearing-house mechanism (CHM), coordination with existing secretariats (including RIMCO and the ISAL) and the treaty's practical implications for polar and regional ocean governance. In this regard, the second webinar under the quarterly webinar series of ASIL – LOSRG – RRU – SMU will explore the following aspects: The legal and institutional transition of BBNJ agreement from adoption to effective implementation; interaction with the existing ocean governance regimes and implications for future rule-making processes in the high seas. Most importantly, BBNJ agreement impact on the polar governance in the Arctic and the Antarctic.



A/Prof Liu Nengye teaches and conducts research on international law and sustainability at SMU. A/Prof Liu is lead editor of three books: *"The European Union and the Arctic"* (Brill, 2017), *"Governing Marine Living Resources in the Polar Regions"* (Edward Elgar, 2019); *"The Law of the Sea and the Planetary Crisis"* (Routledge, 2025); published 50+ refereed journal articles and book chapters in the fields of the law of the sea and international environmental law; and delivered 100+ presentations about his research findings across five continents. He sits on the editorial board of *Marine Policy*, *Ocean Development and International Law* and *Polar Record*. Prof Liu also serves as Co-Chair of American Society of International Law's Law of the Sea Interest Group and a Member of International Law Association Committee on Urbanization and International Law.

Dr Michelle Lim is an Associate Professor in Law at Singapore Management University. She was a fellow on the Global Assessment of the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES) and an author of the IPBES/IPCC joint workshop report. A/Prof Lim was awarded the 2016/2017 Law Council of Australia Mahla Pearlman Australian Young Environmental Lawyer of the Year Award and the 2021 Law and Society Association of Australia and New Zealand publication prize for a published scholarly article or book chapter for the paper: "Extinction: hidden in plain sight—Can stories of 'the last' unearth environmental law's unspeakable truth?." *Griffith Law Review*. 1-32.

## Assistant Professor Rachel Phang



Rachel Phang is an Assistant Professor of Law at Singapore Management University (SMU). Her research interests are in the areas of financial law and regulation, contract law and tort law. Asst Prof Phang received an LLB from the National University of Singapore in 2016, and an LLM from the University of California, Berkeley, in 2021. She was admitted as an advocate and solicitor in Singapore in 2017. Prior to joining SMU, Asst Prof Phang was a researcher at the National University of Singapore's Centre for Banking & Finance Law. Her experience in legal practice focused on financial services regulation, and covered legal and regulatory issues relating to banking, capital markets, payment services, insurance and fintech.


## Looking Forward to 2026

In its first year of operations, the SSFI has established itself as a core sustainability law initiative in Singapore and a global heartbeat for law and sustainability research. 2026 is looking to be a year of accelerated growth for the Initiative. Embedded in a highly supportive academic ecosystem of SMU and the global urban hub of Singapore, the SSFI team plans to deliver a number of exciting projects and events in the coming year. SSFI is also fully aligning its strategy with SMU's Vision as a Global City University to drive innovations, transcend boundaries and transform lives.

SSFI will continue to nurture promising young scholars and change agents at home. We are also looking to recruit a second Yong Pung How Fellow, PhD candidates and Research Assistants. Meanwhile, SSFI continues to attract the best minds to Singapore to address sustainability challenges. For example, Associate Professor Nengye Liu will welcome Prof Helmut Aust (Free University of Berlin), Co-Chair of International Law Association Committee on Urbanisation and International Law to SMU as a Visiting Professor at SMU Urban Institute.

Under Prof Lim's leadership the Sustainable Food Futures Project, funded by the Singapore Ministry of Sustainability and Environment's SG EcoFund will be in full swing.
