1. About the Trusts and Wealth Management Conference

The Trusts and Wealth Management Conference is an internationally recognised biennial conference series convened by the Singapore Management University, Singapore Academy of Law and University of York. The primary objective of this conference is to bring together the leading thinkers in the judiciary, policy makers, scholars and practitioners in the field of trust and wealth management to discuss pressing issues relating on trust law and wealth management. Two successful runs of the conference have been held at the Supreme Court of Singapore in 2015 and 2017. It is envisaged that the third conference will be held in 2019.

The Honourable Sir Launcelot Henderson was the keynote speaker of this two-day conference that brought together the leading thinkers both in academia and practice in the field of trust and wealth management. Speakers from as far as Australia, England, Hong Kong, Hungary, Israel, Liechtenstein, Malaysia and New Zealand discussed how practice and theory interact with modern developments. This conference was regarded as a pre-eminent forum in 2015 for the discussion of trust law and wealth management matters in the common law world. The conference papers will be published as an edited book by Cambridge University Press and will be edited by Professor Richard Nolan (York), Professor Tang Hang Wu (SMU) and Professor Kelvin Low (City University of Hong Kong).

The ambition is to develop this conference series into the pre-eminent forum in Asia for serious discussion on the law and policy regarding trust law and wealth management matters among practitioners, scholars, judges and policy makers. While there are several other wealth management conferences in the market, these conferences do not consider the policy implications and the law in an in-depth manner which results in publications of books and journal articles. Furthermore, these conferences are not often attended by judges and policy makers and therefore merely act as an "echo chamber" amongst the practitioners and/or function as marketing events for practitioners and private banks. In contrast, the Trusts and Wealth Management Conference was well attended by members of Singapore's judiciary and representatives from Singapore's Ministry of Law. The keynote speeches have often featured a leading figure in the English

judiciary. In fact, serious policy discussions have resulted between the Ministry of Law and the conference organisers as a result of the issues raised in the conference.
